STEP 1: Explanatory note

The Waverley Local Environmental Plan 2012 (WLEP) provides for certain minor works to be excluded from requiring development consent (specific to heritage conservation areas and items) if an exemption certificate has been issued in accordance with Clause 5.10 (3). The applicant will be notified in writing before work can commence.

This form is used to apply for an exemption certificate under the clause. Once granted, the exemption certificate allows a person to carry out certain works that will not have an impact on the significance of the heritage area or item.

Please refer to Waverley Local Environmental Plan 2012 Schedule 5 to check whether or not your property is of heritage status.

What works can be granted an exemption certificate?

Minor works that do not have an impact on the significance of a heritage item or conservation area may be granted an exemption certificate, subject to an assessment by Council's Planning and Environmental Services department. However, a certificate will not be issued for the following:

- Demolition
- · Erecting a building
- · Change of use
- Removal/pruning of trees

Your application must be assessed and approval granted in writing before you can proceed with your proposed activity/works. An application fee will apply.
