



## Waste Management Conditions for Promotion and Sampling

To ensure our environment is kept beautiful we adopt the strategies mentioned below.

PROHIBITED	SUGGESTED SOLUTIONS
<ul style="list-style-type: none"> <li>➤ Flyers in Bondi Beach</li> </ul>	<ul style="list-style-type: none"> <li>➤ Flyers printed on recyclable paper are permitted in Bondi Junction if approved under the promotional permit issued to you</li> </ul>
<ul style="list-style-type: none"> <li>➤ Polystyrene must not be used</li> </ul>	<ul style="list-style-type: none"> <li>➤ Waste minimisation and environmentally friendly packaging must be used. They must be reusable, compostable, biodegradable or recyclable. A sample of the proposed food or beverage containers must be submitted for approval before permit will be issued.</li> </ul>
<ul style="list-style-type: none"> <li>➤ The use of plastic: water bottles, bags, drinking straws, inflatables of any kind and glosticks</li> </ul>	<ul style="list-style-type: none"> <li>➤ We do permit up to 60ml or 100g sample size consumable product giveaways in environmentally friendly packaging. If permission is granted for a giveaway then you will need to remove it from any packaging before bringing it to the venue. So we can ensure the packaging is appropriate, we require a sample of the packaging 2 weeks out from event day to be sent to: Bondi Pavilion Waverley Council Outdoor Events, Queen Elizabeth Drive Bondi Beach 2026</li> </ul>
<ul style="list-style-type: none"> <li>➤ One off Sachets give a ways</li> </ul>	<ul style="list-style-type: none"> <li>➤ We suggest giveaways such as reuse bottles or pump pack sunscreen so people can help themselves to it. Plastic or other throw away sample packaging such as sunscreen sachets will not be approved.</li> </ul>
<ul style="list-style-type: none"> <li>➤ Balloons are not to be used, given away or released during events/ promotions</li> </ul>	<ul style="list-style-type: none"> <li>➤ Paper lanterns</li> </ul>
<ul style="list-style-type: none"> <li>➤ Umbrella give-a-ways are not permitted</li> </ul>	
<ul style="list-style-type: none"> <li>➤ No stenciling on ground.</li> </ul>	<ul style="list-style-type: none"> <li>➤ Approved signage submitted in your signage plan</li> </ul>
<ul style="list-style-type: none"> <li>➤ Existing Council bins in the public space cannot be relied upon to cater for waste or recycling material created by special events or promotions.</li> </ul>	<ul style="list-style-type: none"> <li>➤ Waste and recycling bins to cope with the increased demands of the event/promotion.</li> <li>➤ Food waste to be captured if over 20% of the event waste. Event organisers must arrange for organic waste bin and removal</li> </ul>
