Clause 5.9 Tree Preservation of the Waverley Local Environment Plan 2012 applies to all private and public land within the Council area. It prohibits the pruning, cutting down, lopping, topping, ringbarking, removal or wilful destruction of any tree over 5 metres and with a trunk width of 300mm or over at ground level; or canopy spread of 5 metres and a trunk width of 300mm or over at ground level or listed on the Waverley Register of Significant Trees without the written consent of Council, which may be subject to conditions. No street trees, regardless of height, may be pruned, removed or otherwise altered without Council permission. No work on private trees will be carried out or paid for by Council.
