#### p) E Bikes

- i) The meeting was unanimous in the discussion around E-Bikes, the worrying increase in flagrant disregard of road rules and high-risk behaviour of youths especially around our LGA.
- ii) We discussed the increased concern for pedestrian and road safety, obstruction of footpaths and escalating disregard for road rules with e-bikes. We all agreed that e-bikes are motorised vehicles that should be dealt with similarly to other road users, ie licences and insurances required and penalties applied for not adhering to road rules.
- iii) One member of the meeting discussed their concerns with youths and criminal activities witnessed in the local Woolworths store. After a near-miss between their car and youths clad in dark colours no

lights, no helmets on E-bikes on Campbell Parade they sought assistance from the local Bondi Police but was advised that Highway Patrol deal with such matters.

April 1st I attended Eastern Suburbs Community Safety Precinct Committee.

Some from the report I will note at this report and some items and information I will verbally report on the night.

1- Amendment (Vibrancy

Reforms) Bill 2024.

The reforms are part of the NSW Government's

Vibrancy Reforms 2, which aim to encourage the

return of music, live performance, local street life.

Changes commenced on 1 July 2024

• Complainants. The number of people required: to make a statutory disturbance complaint

against a licensed premises will increase from

three to five. They must not be from the same household or business and will be required to prove that they have tried to resolve any issues

with the licensee before lodging a complaint.

Order of occupancy. This will become a central consideration in determining disturbance

complaints

#### Liquor licence application reforms

The primary change to the application process is to remove the 30-day pre-lodgement consultation period and move to a single community consultation model facilitated primarily via the L&GNSW noticeboard .

-Changes commenced on 1 March 2025

Former licensees with a licensee endorsement expiry date within the last 3 years will now be able to renew their Responsible Service of Alcohol (RSA) or Licensee endorsement by completing Licensee Training only.

Prior to the NSW Government's Vibrancy Reforms, licensees were required to complete both the RSA and Licensee training course as the only pathway to renewing their expired endorsements.

# Summary Friends of Biddigal' report May 7th 2025 Background:

- 'Friends of Biddigal' formed in November last year, a group of North Bondi residents concerned about the appalling 'decay' of Biddigal Reserve over the last 8 years. (see past and present photo comparison attached).
- 2. Our Purpose is to generate council and community awareness of the degradation of Biddigal Reserve (one of our most popular natural assets for locals and visitors) over the last 8 years. Specific issues: die back (suspected poisoning) of ten banksias, loss of all native trees and shrubs on the lower eastern section, extensive damage and ageing of pathways, no garbage receptacles, ageing and graffitied sheds, no security cameras or night lighting, weeds everywhere, no landscaping theme of planting random species, no toilets resulting in defecation in gardens.
- 3. Founding members: Jamie Mackay, Rebel Penfold, Michael Darling. Latest events:
- 1. Council meeting on site on 20/2/25. 5 residents and 5 key senior Council staff attended including Carl Nugent Manager, Parks Planning and Recreation. Key issues discussed were the problems associated with erosion and the need to undertake extensive works to replace the retaining walls. These works are not currently in the LEP or funded but Carl 'estimated' around about 2029. In the meantime council

unwilling to replace any trees as they would need to be replaced again in 2029.

Following much discussion with residents attending it was agreed some planting and 'some works' could be undertaken in the upper level of the park, which would not be effected by the major works.

It was also agreed council would consider installing bin receptacles, more playground equipment, repair the numerous safety issues eg. broken pathways, railings etc.

Basically, we were told Biddigal had 'fallen off the agenda and as residents we probably needed to 'lobby harder'. We were also advised there were many neighbours who "didn't want the trees as they blocked their views".

2. On site Meeting 15/4/2025: Jamie Mackay and Michelle Stephenson Bondi Ward Councillor, Waverley Council.

As a local resident and you Mum who attended mothers groupd under the shade of banksias in Biddigal, Michelle was appalled by the state of the park and determined to help.

- Has put forward a motion to undertake specific works in the top level.
- This will include a landscaping plan that recommends appropriate native grasses, shrubs and trees (we agreed avoiding banksias in preference of native oaks, yukkas etc.) replace to broken equipment in the park, installing metal bin containers, redoing the mosaic sand pit, sorting out the weeds.
- Investigating replacing the to sheds with a more aesthetic design.
- Investigating security lighting and surveillance cameras
- Accelerating the necessary repairs to path and railings.
- Ensuring shade is retained in the mothers group area (she was one)
- Recommending increasing the fines for poisoning trees (she was appalled)
- Seeing if we can build the toilets down opposite Speedos sooner rather than later.
- Chasing up our proposal for resident participation in gardening.
- Look what other funds we could access eg. State given it's a reserve.
- 3. On site meeting 23/4/25: Jamie Mackay and Stephen Gilchrist Waverley Council Mgr Parks and Landscapes.

Stephen agreed extensive native planting of grasses and shrubs and weeding would be undertaken over the next two months in the upper park area. Jamie to liase with council on species and location. Stephen also agreed to chase up repairs, bin receptacles, toilets, shed repairs / replacement, park lighting and security camers. Steve is now on leave for a month.

4. Council for residents to undertake community gardening:
