Your assessor will visit you to take your details and register you in the Bin Trim program.

Step 2 It's time for the waste assessment.

Your assessor will review your business waste. This will show you just how much waste your business is throwing away and how much could be recycled.

Step 3 With a plan, you can.

Your assessor will help you get started by creating a tailored waste reduction action plan, and see if your business is eligible for a rebate to help out with buying equipment.

Step 4 With our help, start trimming your bin!

Your assessor will provide practical support and advice to help your business put your plan into action.

Step 5 Measure your success.

With your Bin Trim plan in play, your assessor will conduct a second waste assessment to measure your progress. They give your business:

- · a profile of your waste and recycling
- a tailored action plan to cut your waste
- · advice on how to reduce, reuse and recycle.

Bin Trim Rebates

The **EPA** may help fund recycling and waste avoidance equipment for your business.

What sort of equipment is eligible?

- Cardboard and plastic balers
- Expanded polystyrene compactors
- Shredders
- Source separation bins
- Other (on application)

Who is eligible for a rebate?

- · Businesses with up to 400 employees
- Facility managers responsible for business waste
- Recyclers (conditions apply)

How much funding is available?

Businesses can apply for rebates of between \$1000 and \$50,000, for up to 50% of the purchase price of eligible equipment.

How do I apply for a rebate?

The **EPA** may help fund recycling and waste avoidance equipment for your business.

Step 1 Read up on rebates.

Step 2 Tailor your waste program.

Your waste assessor will look at your waste and recycling needs and recommend appropriate equipment. The equipment must help you avoid or recycle waste that is currently going to landfill. For a free waste assessment and support contact a Bin Trim assessor: epa.nsw.gov.au/bintrim

Step 3 Save and submit.

Submit your rebate application form. Your Bin Trim assessor will help your business do this.

When can I buy my equipment?

Order and purchase your equipment after the EPA notifies you that your application is successful. A rebate will not be awarded for equipment:

- · you have already purchased
- you have entered into an agreement to purchase
- purchased prior to receiving notification of the outcome of your rebate application from the EPA.

When will I receive my rebate?

Once you provide the EPA with proof of purchase, you will receive the entire amount if your rebate is valued at \$10,000 or under, or in two instalments if your rebate is valued at over \$10,000.
