The event aims to revitalise precincts via reclamation of roads for recreation and events and expands on the 2024 Gould St Street Party (part of Bondi Festival). Another event is expected to occur in Spring Street later this year. Saturday in the Park Pop Ups. o Bondi Beach NYE – Residents will be provided with event details in late November and Fuzzy and Council will be running community engagement to answer all resident questions. Background:

Established practice when Council approves a major development with an FSR in excess of the LEP is to seek a planning agreement whereby the developer pays to Council approximately half of the net value increase.

There is now a raft of State Significant Development Applications for major apartment blocks around Bondi Junction. If these are compared to standard controls, there is significant value benefit and in the normal course Council could seek a value capture of approximately half of the net value increase. However, because SSDs bypass Council's planning process, planning agreements may not be entered into with Council. It is not clear how the developer, who stands to benefit handsomely from the approval of an SSD, will be required to share that value uplift. If this is not addressed imminently, the Bondi Junction developers will escape value capture by the community.

Amendment proposed by Tony K: As a matter of urgency, Combined Precincts requests Council to work with State Government to facilitate value capture by Council of SSD related value uplift, through a device with equivalent status to a Voluntary Planning Agreement.

The GM noted that Waverley Council has a reception at the Boot Factory, as well as our two customer service centres (Spring Street and Bondi Pavilion). Waverley Council staff are located at approximately 13 locations across Waverley and our depot at Alexandria. We don't have reception services at all these locations (including the library). Council has processes in place where staff make arrangements for meetings when expecting visitors. Our Boot Factory / Mill Hill reception and Customer Service staff are always happy to assist with any enquiries.

The Director of Community, Culture and Customer Experience suggested that Precinct Packs can now be picked up from Reception at the to Boot Factory.

Peter Q noted he was unhappy with that suggestion as there is no free parking near the Boot Factory.

Director of Community, Culture and Customer Experience noted that The Locals Lawn (the free, family friendly event for 9pm fireworks) is an event that was proposed by our event partner Fuzzy in their submission. This event is being entirely funded and produced by Fuzzy. This is proposed as a "thank

you" to the local community and to provide a safe and inclusive environment for local families on New Years Eve to celebrate and enjoy the 9pm fireworks. Residents of 2026 have been given first priority in the ballot (given that the events are taking place in Bondi), followed by residents of Waverley in other postcodes.

1 The Avenue, Rose Bay (DA-245/2024)

Appears to still be in Court (deemed refusal); amended plans filed with the Court and sent to
objectors. Site benefits from low- and mid-rise reform and therefore benefits from floor space
and height uplift.

Philip Nursing Home at 319-321 Bronte Road, Waverley (DA-94/2021/C)

• Still under appeal. No developments

26-32 Hall Street, Bondi Beach (DA-209/2025)

• Five storey shop top housing development. Existing approvals for four storey shop top housing development, with this new DA adopting the 30% affordable housing bonus. Application deferred 21 August 2025.

40 Ebley Street, Bondi Junction (DA-146/2025)

 Construction of a 12-storey mixed-use development on the NW corner of the intersection with Ebley Street and Newland Street, opposite Clementson Park. Now under appeal at the Land and Environment Court.

Housing Delivery Authority (HDA)

The state government has declared four projects within the LGA (so far) through the HDA. This process results in a concurrent planning proposal (aka rezoning or increase in height, floor space) and state significant development, meaning that they are assessed and approved by the state government. None of the projects have actually been lodged as yet, but would be expected to be lodged in the future. The projects are:

- 36 storey, 900 build to rent apartments across three towers adjacent to Oxford Street Mall.
- 130 apartments at 45-57 Oxford St, 7-9 Denison Street, 2 Mill Hill Road, Bondi Junction
- 20 storey, 180 apartments at 110-122 Ebley Street, 17 Hollywood Avenue, Bondi Junction
- Up to 9 storey, 110 seniors housing apartments at 669-683 Old South Head Road, Vaucluse.

Luke S notes - I was forwarded an email which suggested a motion to 'adopt stronger built-form, heritage and neighbourhood-character policies for Waverely LGA'. The objectives and suggestions were quite extensive and personally, I do believe there is merit in character-specific controls for the locality which aim to reinforce what the public considers desirable development. However, it must be recognised that this is quite a significant change to the planning controls, already overlaps with the existing controls at a local and state level, and would require a lot of forethought and consideration before any controls are change. If the Combined Precincts so desire, they may move a motion that I prepare a supplementary report with the person who suggested the motion so that this can be considered more closely in preparation for the December meeting.
