Comdain the contractor purchased by Service Stream, and they are no longer interested in being the contractor Sydney Water is looking for a new contractor for the entire project

Summary

A decision has now been made to review the design layout for Eastern Reserve to minimize its footprint and visual impact.

Sydney Water has appointed a third party geo-technical service provider to carry out additional investigations and to complete an independent verification of the proposed construction site. After that, an engineering consultant will be engaged to re-design the Eastern Reserve pumping station footprint and the above ground structures. A timeline for this process and any consultation has not yet been set by Sydney Water.

Note maintenance trucks tests was successful in doing 3 point turns so there would be no need for maintenance vehicles to enter the reserve.

Site in Dudley Page at Portland and Lancaster will be site office. Old depot was demolished and existing house to be demolish. Green colour bond fence to surround the site.

Bala said 6 to 9 months to get back to next consultation at 50% design. Sydney Water will take lead role in design and contract with new contractor will be construct only.

Bala promised to look into repairing cracked stairs at Lancaster and Military Rd.

Bala promised to look into refurbishing the Military Road Pump House.

Present finding to Council and seek endorsement to go to the Minister for Lands and Water to adopt

The process for PoM's typically takes between 12 to 18 months to complete depending on the complexity of challenges to address, the requirements for reporting to Council and two review periods with the NSW Department of Planning and Environment (DPE timeframes outside Council's control).

This is the first of three rounds of community consultation. In this round, we need your help to better understand how and when you visit the reserves, which ones are most popular, and what you want to see happen with them in the future.

This is not about planning for capital works or buildings but maintaining a sustainable and community-led approach to the management of the parks and reserves.

Motion 1 - DHP submits to the Coastal Reserves POM that Eastern, Weonga and Raleigh Reserve should have the same 2205 stainless steel for the new coastal fence that has already been mandated by council motion for Rodney Reserve. The steel used in Clarke reserve and Hugh Bamford is a total aesthetic failure with tea staining and corrosion everywhere and council should learn from its mistakes rather than make the same mistake over and over again.

#7 New Coastal Fences in Dover Heights

The current project for coastal fencing is Williams Park. This is currently being scoped for procurement. Yes, this is a new fence to manage high risk edges along elevated cliff lines as identified in the PoM.

A timeline associated with Rodney Reserve fence will be determined, along with other works, through the PoM process. Unless conditions on the reserve or the existing asset condition changes requiring more immediate action by Council similar to any other park asset.

Rodney Reserve is Crown Land. Any substantial development needs to be supported by an adopted PoM or may be an existing land use such as the former playground (i.e. either the existing Coastal Reserve PoM or the new PoM under review) and therefore will be reliant on PoM process.

#8 Pedestrian Crossing

Pedestrian Crossings at Blake and Military as well as at Hunter and Military into Dudley Page Reserve.

Council approved the installation of a raised pedestrian crossing on Blake Street on the eastern side of Military Road at the August Council meeting (picture below). Timing will depend on funding.



Motion 13 - Noting the high use of the reserve by families especially during the weekends which require most people to park on the eastern side of Military Road and the risks that this raises, DHP requests that a pedestrian crossing be installed between Military Road into Dudley Page Reserve at the most used location so parents and children can cross safely.
