Traffic is held up especially on School days and it is difficult to turn right into Macpherson Street from Arden Street going North | We appreciate the feedback and the concerns from the Precinct. This helps us understand areas for improvements over time. We currently have a large volume of investigations to undertake throughout the LGA and are working toward how we can prioritise those. Macpherson St is identified as a key bicycle route. Roundabouts can improve traffic flow, but can create additional safety issues for cyclists, and by extension other street users. There may be alternate control options, but this would require a broader investigation. Council is working with local schools, including St. Catherines to improve active transport opportunities and encourage fewer school-related vehicle trips.
