## **SELF ASSESSMENT**

See the below list for the self assessment check list.

Self Assessment Check List available for use by Pool Owners can be downloaded from Government pool register website or obtained from your local Council.

1. Indoor Pool
2. Spa
3. Swimming pool on a property 2 hectares or larger
4. Swimming pool on a waterfront property
5. Swimming pool on a property 230 square metres or less
6. Portable/inflatable pools
7. All other swimming pools
  - a. Swimming pools built/installed before 1/9/2008 (AS1926.1-1986)
  - b. Swimming pools built/installed from 1/9/2008 to 30/4/2013 (AS1926.1-2007)
  - c. Swimming pools built/installed from 1/5/2013 (AS1926.1-2012)

## **NOTES**

These self-assessment checklists are provided to give the pool owner an indication about whether their pool barrier complies. A professional inspector will use a more comprehensive and technical checklist, that may provide a different outcome.
