Application Details

Documents Required

a) Private vehicles

- Residential and Beach permit: Current vehicle registration showing applicant name and address. The vehicle must be registered to a Waverley address unless applying for a ratepayer or non-resident Beach permit.
- Annual Visitor / Carer permit: Current vehicle registration showing the name and address of the visitor (cannot be registered to the Waverley
 resident or address).
- Short Term Visitor / Tradesperson Permit: Vehicle registration number only.

b) Company or lease/rental vehicles

- Company Vehicles: Current vehicle registration AND
 - Employee a letter from the company on letterhead with an ABN confirming the applicant has use of the vehicle and it is parked at the Waverley address.
 - · Director ASIC Report showing applicant name (Note: Directors cannot write their own letter).
- Rental / Lease Vehicles: Current rental agreement showing applicant name and vehicle registration number.

c) Car spaces at the property (applicable to Residential permit applications)

- All car spaces MUST be occupied with a registered vehicle (see Private/Company vehicle information above).
- · Vehicles occupying car spaces are not entitled to individual residential permits.
- · You MUST provide a current vehicle registration for each vehicle occupying a car space (see Section b above).

d) Carer Permit

Provide ONE (1) of the following documents:

- · Proof of Employment on letterhead from a Registered Organisation (e.g. Centrelink, Mission Australia).
- · Doctors Certificate on letterhead naming the carer of the resident who resides at the address.
- Statutory Declaration signed by a JP naming the carer of the resident who resides at the address.

Parking Permit Fees

Current Parking Permit fees are located on the website at waverley.nsw.gov.au/residents/parking/permits.

Additional fees:

- 0.8% surcharge applies to credit card payments.
- Administration fee applies for the transfer to a new vehicle or reprint of a lost, damaged, or stolen permit (a police report or statutory declaration may be required for replacement of some permit types).
