**Acknowledgement of Country**

All precinct attendees on the Zoom call were then asked to turn on their video cameras.

The meeting was told here was an apology from Alana Novak, Council's Community Planning Advocate, who was scheduled to attend the night's precinct meeting. The convener told the meeting there were several issues that residents wished to raise around Private Certification and the state of Bondi's residential roads, particularly O'Brien Street.

The meeting was told Ms Novak was now scheduled to attend Bondi Precinct's first meeting of the year in 2024. This will be held on Wednesday 21 February via Zoom.

# **Matters arising from August Meeting**

The Convenor went through the Response Report that was prepared by Council. The response report was shared onscreen with the meeting.

## Summary of matter's arising:

- Large scale development causing damage to Bondi's residential streets.
- Bondi Precinct had requested a parking review for area 4, including 15-minute free parking in Hall Street.
- Bondi Precinct requested advise about what can be done to mitigate existing and future loads to hydrology infrastructure in Bondi Basin.
- Bondi Precinct to draft letter about flooding and send to relevant officer.

#### **Private Certification**

Bondi Precinct has repeatedly asked that all Waverley residents have access to information on private certifications and direction on where residents can turn if there are problems.

The convener told the meeting Ms Novak had sent through information, and this would be uploaded to the council's website so residents had a clearer idea of what their rights were.

A resident then provided an update to the meeting, on his long running case with PC. The resident told the meeting he was greatly unhappy with the situation regarding his property. He said "a number of" emails had been sent to Council since the stop work notice was issued on site. He said there had been no response to those emails in 12 months. He had also been asked by council to "resend" his submission, and relevant emails provided.

Clr Goltsman told the meeting State Government legislation gave Private Certifiers authority in this area. Councils had been left out of it. Clr Goltsman told the meeting if the resident put the request for a response in writing and sent to him, he would make sure the resident received a reply.

The convener thanked Clr Goltsman.

Clr Wy Kanak told the meeting a motion did go to Council in September (12 September 2023) to be taken to the LGNSW 2023 conference. https://waverley.infocouncil.biz/Open/2023/09/CM 20230912 MIN 726.PDF

Clr Wy Kanak said the issue was not settled yet and the council would be pushed to answer the list of 12 or so questions put forward by the resident.

### State of Bondi's roads:

The convener told the meeting the residential roads in Bondi Precinct were in poor condition.

Roads had been dug up by trucks, and large heavy construction vehicles, particularly in O'Brien Street and Sir Thomas Mitchell Road. Many people had concerns about damage to homes and vibrations.

A resident told the meeting some resurfacing had been done in O'Brien Street

where the excavation had occurred, and it had helped, but it was only a band aid solution, and it wouldn't be long before the ridges reappeared, and houses

were shaking again.

Another resident spoke of the distress that was caused by heavy vehicles,

including buses, "thumping" over the ridges on O'Brien Street, and the

subsequent house vibrations it caused.

Clr Wy Kanak told the meeting some work had been done on O'Brien Street

but final fixing of the trenching of the road surface had to be done at the end

of construction. They could do patches, but final work wouldn't get done until

final work has been finished.

Another resident said it wasn't just the surface area of the road that was an

issue. The problem was the sub strata of the road, which could not sustain the

weight of the vehicles going across them.

Bondi Precinct requests a meeting with Waverley's General Manager, Emily

Scott, to discuss priorities for repairing the poor standard of Bondi's residential

streets.

Bondi Precinct also requests a copy of the capital works program and the

budgeting for 2024-2025.

Bondi Precinct had been asking for 15-minute free parking in Hall Street for

precinct resident so they could do their shopping without being booked.

Council had responded that 15-minute free parking spots existed in Hall Street.

parklet.

have access to 15-minute free parking in Hall Street.

Bondi Precinct believes the 15-minute free parking spots currently provided

are not operating as successfully as they could.

For many months a parklet has operated outside 77/79 Hall Street, a spot

designated for 15-minute free parking. BP requests that the parklet be

removed so the spot can once again be used for 15-minute free parking.

**Development Applications Update**

Also, 22-26 Edward Street, originally slated for affordable housing. An

amended DA has been submitted, replacing the affordable housing with four

luxury units.

The removal of a large established avocado tree in the laneway between Sir

Thomas Mitchell Road and Lamrock Avenue was raised. The tree was removed

to make way for underground car parking.

**Hydrology** 

The meeting was presented with a letter drafted by the Precinct, that

highlights the need for a basin-wide hydrology report and requests a copy and

walk through of the last available report done for all resident's future planning.

this issue between the Waverley Mayor, Paula Masselos, and the NSW

Minister for Lands and Property, Stephen Kamper MP.
