- *In accordance with the Cemetery's Conservation Management Plan, any proposed memorialisation must be in keeping with the existing and surrounding memorialisation, predominantly Sandstone, Carrara Marble, and / or Light/soft Coloured Granites.*

### Religious, Cultural, Aboriginal Requirements
